



Hand Therapy Around the World: Merida, Mexico

eet Mariana Güémez, an Occupational Therapist who is currently practicing occupational therapy and hand therapy in Merida, Mexico at Rehabité. Merida is located in the Yucatan Peninsula and is the capital of the state of Yucatan. Mariana completed her degree in occupational therapy at Brenau University in Gainesville, Georgia.

How many years did you spend in school to become a therapist?

Five years in Mexico to become a rehab specialist and almost three years to become an OT at Brenau University in Gainesville, Georgia, USA.

Why did you choose to go to Brenau University instead of a local school?

First of all, at that moment, there were not local schools in Mexico for OT. Also, I always wanted to study in a different country. I was looking for the best education possible and professors with great knowledge and experience.

Did you have a plan when you returned to Mexico?

Yes, I wanted to start my own company. I am still far away from having all the tools and equipment necessary, but I'm working on it.

Why did you want to go into practicing hand therapy?

I was fascinated by orthotics and the idea of learning new and different skills. Also, hands are so important in order to complete ADLs and every time that I see patients with injuries, I question myself about my knowledge and abilities to get them back to normal (work, school, home, etc.).

Describe the setting that you work in.

My working hours are from 9 AM to 8PM. I treat patients of all ages in the neuro, orthopedic and pediatric populations. I work with speech therapists, physical therapists, psychologists and doctors. I treat about 10-20 patients per day for about one-hour treatments and see patients anywhere from 7-20 sessions on average. We do use modalities and make splints as part of our treatments if needed. Also, I take students and love teaching.

What are the common conditions that you see? Are there any rare conditions that you have come across?

Common conditions I see include boxer's fractures, nerve injuries, elbow and shoulder surgeries and carpal tunnel syndrome. For rare conditions, I have seen some rare lymphomas.

What was the most creative solution you have done or the most challenging thing you faced?

We do splinting with recycled materials. Sometimes we receive patients after bad surgeries and it is really challenging to get them back to normal.

What are the relationships like between the physicians and the therapists?

It really depends on the doctor.

Sometimes we are a great team. The doctors are typically very involved in the patient's care. Specific decisions made for the patient's treatment are usually made by both the therapist and doctor.





How do patients pay for treatment?

Some patients pay with insurance and some pay with cash.

Is there a hand therapy community in Mexico? What are the continuing education/mentoring opportunities available?

There is not a hand therapy community in Mexico. Continuing education and mentoring opportunities are very poor for

OT. Actually, I'm making a program that I would like to teach.

What is your favorite part of your job or setting? What is something in your setting that is challenging?

My favorite part is getting to know more about my patients. Getting involved in their lives. I love that I am very fortunate to have a great team. Regarding challenges, I would love to have more rooms or a bigger gym. I wish I could get orthotics-fabrication material more easily.







- Deliberate intimidation or stalking:

- Sustained or repeated disruption of talks or other events:
- Express or implied threat of physical or professional barm:
- Actual or threatened personal or professional retaliation for a rejection or report of unacceptable behavior;
- Failing to stop unacceptable behavior when requested by a Participant or ASHT.

REPORTING UNACCEPTABLE BEHAVIOR

CONSEQUENCES OF REPORTED UNACCEPTABLE BEHAVIOR

INNOVATION AND COLLABORATION:

The Key to Advancing Hand Therapy Interventions and Practice

ithout innovation, health care practices would stagnate and the development of progressive treatment interventions would not be achieved.1 Further, without effective collaboration, these innovative practices would be limited in both development and application.^{1,2} As advances in technology surge in healthcare, regardless of the area of application, these ideas are motivational to many hand therapists as they develop strategies to address the needs of the upper extremity patient population. In addition, as technology progresses seemingly every nanosecond, it is imperative that hand therapists understand the importance of their ability to advance the future of practice with their unique ideas. A key to this advancement is understanding the importance in reaching out and collaborating with other specialists in order to advance those concepts. 1-3 This article focuses on the concepts of innovation and collaboration in healthcare as well as concentrating on the newest concepts impacting the future of hand therapy practice.


Collaboration between Healthcare and Technology

Why is it so important to collaborate with those who understand technology in this era? With the inspirational ideas many therapists gain during practice there is always the opportunity to take these epiphanies to another level that could benefit so many. This is where our profession embraces collaboration to take these concepts to a level of higher advancement. This may be with fellow health care professionals in other disciplines such as

prosthetists, orthotists, nurses or those in ancillary professions such as engineers.^{4,5} Research has demonstrated that diverse professions have joined together to contribute to advancement in clinical practice.^{2,4} The concepts of telehealth, digital collaboration and education have expanded the realm of healthcare. Ironically, the era of the pandemic has actually contributed to the way healthcare professionals communicate with patients. The predominant examples of collaboration in the post-COVID age are in technology and the ability to apply multiple concepts in conjunction with traditional clinical and educational platforms.^{2,6} The post-pandemic era has actually facilitated the realization that technology and healthcare can collaborate to promote remarkable and valuable interventions.7

Current Innovations in Rehabilitation and the Importance of Collaboration

Embracing the wave of technical advancements in healthcare, the field of hand therapy has benefited from collaborating with specialists in the areas of prosthetics, orthotics, engineering and information technology to research and implement innovative approaches including 3D printing, robotics and virtual reality. ^{4,8-10} It is exciting to consider the importance and impact skilled hand therapists can make upon individuals with upper extremity impairments ranging from traumatic amputations, limb replantations, neurological and orthopedic conditions and chronic pain ⁵.

3D Printing

An area of innovation that is currently evolving is 3D Printing and the capabilities this technology has to offer to hand therapy interventions is promising. This method allows for hand therapists to work collaboratively with technicians such as Rehabilitation Engineers who specialize in 3D digital imaging to generate custom orthoses and prosthetics through this innovative technology that allows for specific customization. ^{10,11} 3D printing is developing very rapidly and may be applied so precisely that it is imperative hand specialists understand the applications of this new technology in order to incorporate these strategies into practice. ^{10,12}

3D printing allows therapists to not only create prosthetics and orthoses but also specific assistive devices conveniently and at a nonprohibitive cost to clients. ¹¹ This approach also benefits educators as models can be customized to demonstrate normal and abnormal arthrokinematic motion and various pathologies. ¹⁰

Robotics

As technology progresses, the opportunity to provide patients who are amputees at all levels with the ability to function with myoelectric prosthetics is advancing. These devices allow amputees to resume independent function and precise digital motion with the use of myoelectric sensors.¹³ Additionally, the use of soft robotics

combined with functional electrical stimulation has been found to to profoundly aid in the recovery of hand function in both spinal cord injury and stroke patients. ^{12,14} These exoskeleton devices assist in recovering digital motion associated with neurological functional impairments thus expediting the return of functional motion.

Virtual Reality

Taken from the high-tech world of gaming, this new approach to hand therapy is found to be highly successful in addressing phantom limb pain, complex regional pain syndrome (CRPS) and both traumatic and congenital limb deformities that present with impaired motion. This approach is highly collaborative with biomedical engineers and hand therapists working together, often also using 3D printing, to generate game-like programs that allow patients to promote motion in a motivational way.^{8,9} By allowing a patient to experience

the sensation of normal motion without pain or patterning. This new technology is cost-effective and inspires patients to move thus expediting the return of function.

Understand the Evidence

Technology is advancing swiftly and clinicians must understand the evidence and conduct their practice responsibly. It is also imperative that hand specialists grasp these advancements and further promote the practice based on their skilled perceptions and innovative concepts through collaboration with colleagues in the areas of prosthetics, orthotics, neurology, wound care and rehabilitative engineering.¹¹

It is imperative that when a practitioner has an innovative idea, they embrace it, document it, and collaborate with colleagues to advance these concepts. Without these visions, and these moments of enlightenment, we will not go forward. The people

you will help with your ideas, and the others you will inspire are unfathomable. The key to innovation and collaboration for both clinicians and educators is to network to develop and expand ideas. ASHT is an excellent platform to reach out and begin networking with colleagues. Do not let a brilliant and innovative idea go without a vision and voice. Are you the spark?

THE HANDERBILT WRAP

Introduction

Ulnar drift is a common occurrence in individuals with rheumatoid arthritis (RA), affecting approximately 44% of people within the first ten years of disease onset. This deformity, characterized by the fingers deviating towards the ulna, can result in considerable pain, joint instability, weakness and impaired motor coordination. This condition negatively impacts daily activities requiring hand function such as writing, self-feeding, gardening and manipulating tools and objects, impairing quality of life. A Therefore, understanding the causes and management of ulnar drift is required to develop effective interventions for our patients.

Biomechanics of Ulnar Drift

Several biomechanical factors, including radial collateral ligament attenuation and degenerative changes in carpal and metacarpal anatomy, cause ulnar drift in patients with RA.1 Joint synovitis destroys the hand's structure, leading to ulnar subluxation and displacement of the extensor tendons and interossei musculature. Wrist synovitis can lead to a zig-zag deformity as the metacarpals radially deviate, the transverse arches flatten and the digits drift ulnarly, resulting in a biomechanical deficiency of the hand. 1,2 The ability to extend the fingers and maximally open the hand is reduced as the tendons have lost mechanical advantage due to their position now resting ulnarly to the metacarpal heads. These biomechanical changes within the joints make it necessary to use both hands to pick up larger objects and effectively manipulate smaller items.2 While earlier theories, such as gravity-induced deviation, have been disproven, activities that increase lateral forces to the digits can contribute to deformity and dysfunction.1, 2

While traditional orthoses offer valuable benefits, they may also have practical limitations.

Orthotic Management

Orthotic interventions can improve joint alignment and reduce stress on affected tissues by providing lateral support to the metacarpal phalangeal joints (MPJs), promoting stability during functional activity. The Metacarpophalangeal Ulnar Deviation (MUD) splint (orthosis) described by Rennie in 1996 includes a hinged proximal phalangeal component as well as individual finger straps that apply radial force to the ulnar side of each proximal phalanx. Rennie's research supported using orthoses in managing ulnar drift, as the orthosis significantly improved anatomic alignment and three-point pinch strength.² However, the orthosis did not significantly affect hand function scores, pain scores, gross grip strength, or lateral pinch strength.² Patients reported high acceptance of the orthosis: 79.2% indicated minimal interference with activities of daily living (ADL), 95.8% were satisfied with appearance, and 87.5% were satisfied with comfort.² It is not suggested that long-term use of an orthosis can change disease progression. Rather, using an orthosis can help manage symptoms or delay negative effects from mechanical wear and tear of the affected joints.

While traditional orthoses offer valuable benefits, they may also have practical limitations. Rigid materials can be bulky, uncomfortable, and potentially harmful to fragile skin. 5 Complex designs require significant time for custom fabrication and

maintenance, even for experienced hand therapists, equating to high labor and materials costs. As a result, the need for a simple yet functional design led to the development of the Handerbilt Wrap. The evolution of orthotic designs reflects efforts to balance orthotic support and practical daily functionality, ensuring that patients with upper extremity impairments can maintain hand function and quality of life while managing their diagnoses.

What is the Handerbilt Wrap?

The Handerbilt Wrap is an innovative orthotic intervention designed to support the MPJs and protect against ulnar drift. One of its primary benefits is its low cost, making it an affordable option for patients and healthcare providers. The simplicity of its design ensures that it can be easily fabricated, even by those with limited orthotic fabrication experience, using minimal and low-cost materials, thereby lowering overall healthcare costs. The neoprene material conforms to the hand, providing gentle yet effective support for potentially fragile skin while allowing for a functional range of motion of the hand. These design characteristics can promote patient participation in their preferred activities of daily living.

Orthoses are crucial in managing this condition, providing support, improving joint alignment and enhancing the hand's overall function.

This neoprene orthosis is designed to wrap around the palm and fingers. It is important to consider contraindications before using this type of orthosis to ensure safe and effective treatment for conditions such as open wounds, unstable fractures, or allergies to neoprene.

A Challenge to Manage

Ulnar drift in rheumatoid arthritis remains a challenging deformity to manage due to its multifactorial etiology and significant impact on hand function. Advances in orthotic design, such as the Handerbilt Wrap, offer new avenues for effective management, emphasizing the importance of continued innovation and patient-centered approaches in treating RA hand impairments. Orthoses are crucial in managing this condition, providing support, improving joint alignment and enhancing the hand's overall function.

Ulnar Collateral Ligament Injuries and Rehabilitation

Ulnar Collateral Ligament (UCL) injuries are frequent injuries of the overhead throwing athlete, particularly baseball players and can lead to Ulnar Collateral Ligament Reconstructions (UCLR).¹ Treatment of these injuries may vary contingent on your operating physician and facility preferences. Referrals may be pre-operative, post-operative (repair vs reconstruction) or conservative. Patients will display varying levels of intensity and repetitive stress at the elbow complex, pending their level of play. It has been found unanimously that risk factors include overuse, high velocity, poor mechanics and previous injury.²

Clinicians display varying levels of experience and preferred treatment methods. There are several provocative tests clinicians may utilize and the progression of a rehabilitation program through the guidelines of the referring physician. My personal clinic experience has consisted of treating UCL repairs, "Little League Elbow", partial and mixed partial thickness tears with a greater amount of conservative rehab over post-operative. During the evaluation process, it is important to assess their intensity, level of play and stage of healing. Ligamentous structures take 12-14 weeks of healing and maybe 6+ months before a high level of play.

When I initiate the evaluation process, at my current clinic I generally see them when they are nearly fully healed, unless it is post-operative. We have a structured program which I issue pending pain reports and potential motion issues. Stability is very important to assess and educate on avoiding valgus stress and what valgus stress looks like. I will ensure they have a concrete understanding of what their rehabilitation will look like and collaborate on their goals. Our current program consists of a slow progression of effort level and amount of throws to supplement strengthening. At times iontophoresis or ultrasound may be needed to decrease inflammation and promote soft tissue healing pending their response to the program and reported symptoms.

As treatment begins, I begin with a warm-up, performed in a proximal to distal progression. I start with thoracic stretching/ strengthening and challenge rotation as needed. I will also incorporate proprioception and stability. I feel it is important to increase anterior and posterior shoulder capsule strength and stability. As the program progresses I am ensuring they are working on the program on their own and supplement problem areas and pain control as needed. Living in a midwestern state, it is common to modify the environment for throwing which is often completed indoors. I will frequently remind them the greatest stress to the UCL is during the late cocking phase of throwing. With our current programming, patients are satisfied with their strength and throwing abilities following their injuries and confident with their performance. Close monitoring is utilized to ensure they are not susceptible to reinjury and if they need to be followed peripherally.

Clinicians and facilities have their preferred methods and treatment to injury is frequently changing. Different perspectives and new techniques to supplement communication are crucial to progress the profession. Hand therapists play significant roles in providing a safe and monitored program regarding sports injuries. Communication with the physician, parent and athlete ensure successful outcomes. Prevalence of Positive Modified Scapular Assistance Test in Patients with Shoulder Pain with and without Scapular Dyskinesis: a Cross-Sectional Study

Scapular dyskinesis (SD) is a condition involving altered scapular position and/or motion, often associated with shoulder pain (SP). While SD's correlation to SP is debated, it is commonly assessed by hand therapists using methods such as visual assessment and tests such as the modified scapular assistance test (mSAT). This study aimed to determine the prevalence of positive mSAT results in patients with SP, comparing those with and without SD. The hypothesis was that patients with SD would have a higher prevalence of positive mSAT results due to the test's impact on scapular motion and position.

The study included patients aged 18-70 with musculoskeletal shoulder impairments in a public hospital in Argentina. Participants were assessed via the mSAT, the scapular dyskinesis test (SDT) and pain. Results showed no significant difference in the prevalence of positive mSAT between patients with and without SD, challenging the notion that mSAT results are strongly correlated with SD presence in those with SP. The authors advise against using the mSAT alone for SD assessment and treatment decisions.

Understanding the limitations of the mSAT in isolation for assessing SD is crucial for hand therapists involved in shoulder rehabilitation. This study emphasizes the need for a comprehensive evaluation rather than relying on a single test to guide clinical practice decisions. Hand therapists should integrate multiple assessment tools including patient-reported outcome measures, pain scales, A/PROM, MMT and provocative tests of differential diagnoses to develop personalized rehabilitation plans. This study also underscores the importance of ongoing research to refine assessments for individuals with SD and SP. Incorporating evidence-based practices and a holistic approach to shoulder rehabilitation can lead to better clinical outcomes and occupational engagement for patients.

Quiz Answers

1. Answer C

Involves immobilization of accurately aligned bone ends and creates a smaller and weaker primary healing medullary bone callus than secondary healing. Functional Fracture bracing provides secondary healing which creates a periosteal callus formation which is stimulated by motion at the fracture site. The bone ends move on each other and create a vascular reaction, stimulating capillary invasion from soft tissue to fracture site, increasing osteogenesis and quicker union of the end of the fractured bone.¹

2. Answer D

A pressure garment is not needed for a superficial-thickness burn wound. 24-28 Hg. is used for prevention, control, and correction of scar hypertrophy. 40 mmHg can be destructive to tissue and cause paresthesia.²

3. Answer C

Case studies are subject to significant bias due to lack of controls and the influx of experience and/or opinions³

This also can be used as an exercise for the patients' HEP to focus on regaining ROM.
